Dan Brown to Receive the Joe Lisy Award

Created in 1959, the Joe Lisy Award is given annually in the memory of Joe Lisy for outstanding service to the Chicago Section. Joe Lisy worked tirelessly behind the scenes; eagerly doing anything that would help the flow of a program or an activity. He anticipated and compensated for every possible problem that any Section activity might encounter. Joe Lisy never drew attention to himself; instead he always managed to pass the credit on to someone else.

After his death, the Chicago Section established the Joe Lisy Award to recognize exemplary members for their unselfish contributions to the Chicago Section. It is in this spirit that this year's selection was made.

The Joe Lisy Nominating Committee and the Chicago Section Board proudly announce the selection of Dan Brown as the recipient of the Joe Lisy Award for 2008.

Dan Brown has been a quality professional for over twenty (20) years in a variety of industries, including chemicals, pharmaceuticals, medical devices, nuclear suppliers, sales incentives, warehousing/distribution, and machinery rebuilding/repair. He has held a variety of positions, starting with Quality Control Laboratory Technician and progressing to Quality Assurance Coordinator, Quality Assurance Manager, Operations Manager, Quality Systems Auditor and Management Representative for Quality.

Dan has been a member of the American Society for Quality since 1987, a Senior Member of ASQ since 1993, and an ASQ Certified Quality Auditor since 1989. He has also held numerous positions on the Board for the ASQ Chicago Section. Presently Dan is the Vice-Chair of Membership. Dan has been named Chair of the 2008 NIQC, Northern Illinois Quality Conference.

Dan is an instructor for the Training Institute of the Chicago Section of ASQ, and a Competent Toastmaster in Toastmasters International. He has performed training in Food, Drug & Device GMP regulations, ISO 9001 & 14001, Continuous Improvement, Root Cause

OSHA Training

The Pampered Chef is hosting **10-hour OSHA Training** and **30-hour OSHA Training** on June 16-19, 2008, at The Pampered Chef, One Pampered Chef Lane, Addison, IL. The training will be presented by **STAC: Safety Training and Consulting, Inc.** This course is intended for private sector employees and employers from all types of general industry. It is designed to present detailed information on how the provisions of the OSHA Act must be implemented in the workplace. It

will include in-depth review of OSHA's General Industry Standard. Participants who successfully complete the course will receive a 10 or 30-hour completion card from federal OSHA. Topics include walking and working surfaces, exit routes, emergency action plans, fire protection, hazardous materials, personal protective equipment, machine safeguarding, and more. The instructors, William J. Pfister, Robert S. Pfister, and Lee Kraft, Jr. have extensive experience in industry and in the OSHA standards, and they make the training interesting and a fun experience for everyone.

Cost of the training is \$595 for the 10-hour training and \$895 for the 30-hour training. The OSHA Standards 2nd Edition and STAC training binder, as well as all lunches, are included in the cost. Congratulations to the ASQ High School Scholarship Winner—Tim Brown

The ASQ Chicago Section 1201 has awarded the 2007-2008 Maurice Maurer Memorial Scholarship to Tim Brown, a student at Lyons Township High School. Tim will be studying civil engineering at college starting this fall. Tim's winning essay is printed below.

2007-2008 Scholarship Essay By Tim Brown

Quality has been stressed throughout my whole life. Whether it was quality schoolwork, housework, or just quality time with my family and friends, I have been raised on a quality basis. This is evident in school where I maintain a weighted Grade Point Average above 4.0.

The school that I currently attend is Lyons Township High School. There I am studying and have studied many classes to enhance my college education such as Trigonometry, Pre-calculus, Physics, English Literature, and both Spanish and Chinese. All of these courses are at accelerated levels and will help with my general education plans in college.

Driving Supplier Excellence Through Auditing

Many of you work for companies that audit their suppliers or where you are audited by your customers. For most of us, these audits tend to become fairly routine: a fill-out the form and go home early routine. Such audits are little more than a waste of resources and give lie to the promises of ISO 9001, especially a reduction or elimination of such audits.

What then shall we expect from a supplier audit program? We expect to reduce our corporate risk. Risk examples include: product failure, hazardous components, poor fit, contamination, delay, sub-grade materials. In considering risks, consider past performance. Don't start with the top suppliers who have no history of problems. Rather, start with the suppliers who provide critical components but have also had a few "hiccups" along the way. These are the ideal targets for development. Let us then consider how supplier audits can reduce these risks.

First, meet internally to clarify and document your supplier expectations. This meeting must include a Purchasing representative and should include representatives from Production, Inspection/QC, Engineering, and even Finance. Your expectations should fit into the corporate mission and corporate quality objectives. Your expectations should be measurable, achievable, and realistic.

Second, provide those expectations to your critical suppliers. These suppliers are the ones who represent the top 20% of your vendor concerns. Vendors of critical components, large volumes, and also those who have been particularly troublesome over the past few years are your target. You should not send these off in a form letter. Instead, call your quality contact at the suppliers and discuss your initiative and expectations.

You should engage the supplier in a dialogue to explain what you are doing and why. The goal is to bring them aboard in a proactive manner and not to create tension. Do not be surprised if you are not warmly received. Few companies welcome more effort and tighter supplier requirements, especially if there is no promise of additional purchases. Be prepared to negotiate in order to gain their acceptance. This is made easier when Purchasing works with Quality in this initiative. Purchasing's expectations of suppliers must be the same as the Quality Department's or you will fail.

Third, throw away your ISO 9001 audit checklist. In many cases, your supplier is already ISO certi-

fied, in which case someone else has already evaluated their general management system, so why repeat it? Instead, create custom checklists based upon your stated expectations. Remember that above all, these on site audits are your face time with your suppliers and that you are in charge. Be prepared to not only audit them, but to offer them training as well if your audit determines that they are lacking in areas critical to your specialized needs.

But wait, isn't this a conflict of interest to train the supplier on what we are require of them? **EMPHATICALLY NO!!** Large companies do this all the time. Ford offers training to its suppliers in everything from FMEA & 8D to TS 16949 compliance. Motorola and GM offer Six Sigma training to their suppliers. The important thing in avoiding a conflict of interest is that you are merely teaching them to use a tool (or a set of tools). They are still responsible for the implementation and on-going use of these tools. And you are building relationships at the same time.

If you are going to increase your demands and expectations of your suppliers, then your suppliers have a right (and a fiscal responsibility) to ask demands of you. These demands may include increased cost or minimum order sizes or minimum contract lengths so that they cover the implementation costs. Your ability to work with them and create long-term partnerships will go a long way toward alleviating their worries about the implementation costs. One look at the Toyota model gives evidence of the success of such supplier partnering compared with the continuing bankruptcies of suppliers to the so-called "Big 3".

Do you expect design controls? Lean Deliveries? PPAPs? Six Sigma? Coach and lead them. It makes a significant difference when the customer leads by example instead of by decree. Suppliers know when their customer practices "Do As I Say, Not As I Do." By being open, sharing your successes (and failures), and teaching them the tools your company uses (and expects from them) you will gain their trust and provide the basis for growth. Indeed, you should even invite your suppliers to your facilities to see how their components are incorporated into your products. You can even bring your suppliers with you to your customers to see how the final product is used. This will reinforce the importance of their work and provide a sense of pride in a job done well.

Lincoln Award Update

You're too late for this year.

If you already haven't sent your application in to become an Examiner for the Lincoln Award for 2008, you've missed the deadline. And if your organization hasn't applied to be examined against the Baldrige Criteria, receive a written feedback report outlining its strengths and its opportunities for improvement, and be recognized for its journey towards excellence, it is also too late. You and your organization will have to wait until next spring.

But don't despair. Even though you're not involved in the formal process, you can still use the Baldrige Criteria for Performance Excellence as a framework for your improvement journey.

Why use the Baldrige Criteria? Simple – it provides a framework for this journey based on the best practices of world-class companies. While it identifies what you need to consider to achieve excellence, it is not prescriptive and doesn't tell you how to do it. What it does require is

- *Systematic, integrated* approaches for all key requirements that are fully *deployed & aligned*,
- *Fact-based evaluation and improvement* leading to breakthrough and *continuous improvements*,

- *Improvement trends* in results for *all key performance measures*,
- *Good performance relative to competitive and comparative organizations*.

Using the Baldrige Criteria will help drive you to be a *Role Model* organization.

A good way to learn about the criteria would be to attend a "Champions for Excellence" course, sponsored by The Lincoln Foundation. The training will be in Naperville at Tellabs on August 12-13. A case study will be used to assist attendees in gaining an understanding of the criteria and learning how to use it within their own organizations to increase performance. Registration information can be obtained at: www.lincolnaward.org. ASQ members will be given a 25% discount so the two day training program will be \$400 for ASQ members only.

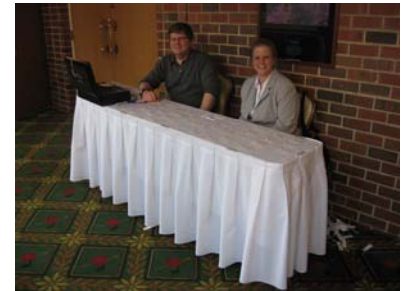
